ACTIVITIES OF THE CELL

- To take all reasonable steps (active and preventive in nature) to prevent the harassment occurring.
- To address any oral/written complaint about: unwelcome sexual advances, unsolicited acts of physical intimacy, unwelcome requests for sexual favors or other unwelcome conduct of asexual nature.
- Display anti-sexual harassment posters on notice boards.
- Conduct regular awareness raising sessions for all students and staff on sexual harassment issues.
- Ensure that complaints processes: are clearly documented, explained to all, offer both informal and formal options for resolution, address complaints in a manner which is fair, timely and confidential.
