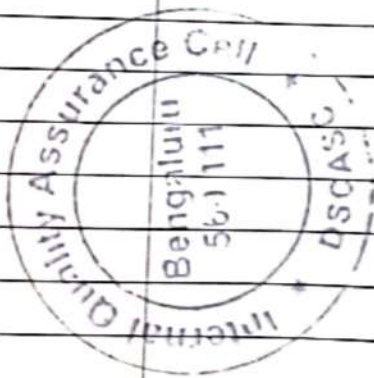

The programme is also aligned with Sustainable Development Goal 10 - Reduced Inequalities, which promotes social inclusion, equality, and equal opportunities for all.

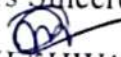

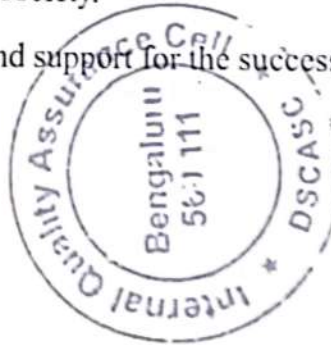

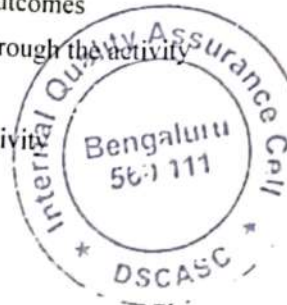
